

IRVING ISD PARAPROFESSIONAL SALARY SCHEDULE #4

2005 - 2006

Eligible employees in TRS and working at least 30 hours per week will receive \$41.66/month for a State benefit supplement not included in the Salary Schedule. For a period of 12 months, this would equate to \$500 in addition to IISD Salary for each eligible employee in TRS. Those specifically excluded from the State benefit would be eligible for the District Off-Set Benefit of \$41.66/month.
