

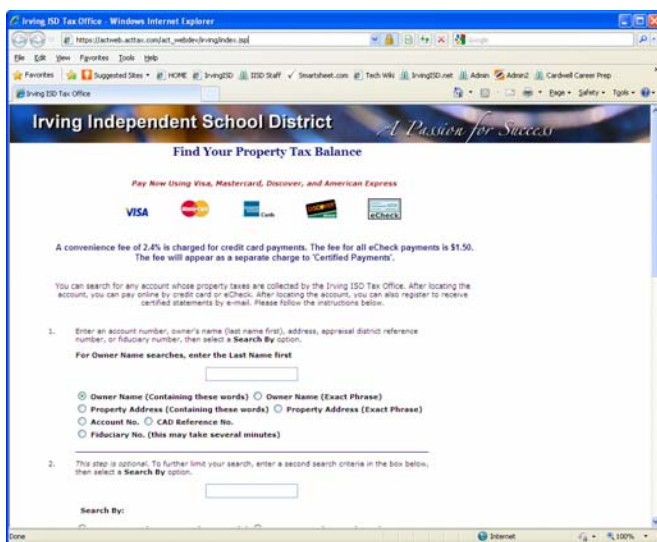


Automatically Receive Electronic Tax Statements

Residents living in the Irving Independent School District can have an electronic copy of their school tax statement sent to them automatically each year. You have to go online and sign up for this free service.

Below are the steps involved:

1. Access the online system by going to https://actweb.acttax.com/act_webdev/irving/index.jsp



2. Enter in your last name in the first box, click on the button for "Property Address", then enter part of your street address in the second box. When done click the SEARCH BUTTON.

1. Enter an account number, owner's name (last name first), address, appraisal district reference number, or fiduciary number, then select a **Search By** option.

For Owner Name searches, enter the Last Name first

2. This step is optional. To further limit your search, enter a second search criteria in the box below, then select a **Search By** option.
